Contractors - As introduced, punishes as theft certain actions of persons performing home improvement services; requires the board of licensing contractors to post information on its web site when the board disciplines a contractor or home improvement service provider or contractor; requires the board to revoke a license it issues in certain circumstances. - Amends TCA Title 39; Title 47 and Title 62.
